Our community hospital began in 1949 when the West Orange Healthcare District was created by the Florida legislature. We opened our doors in 1952 as West Orange Memorial Hospital in Winter Garden, Florida, serving the rural community's surgical, maternity and general health needs. To meet the needs of our growing community, West Orange Memorial Hospital closed and re-emerged in 1993 as Health Central. Situated on a 90-acre campus in Ocoee, this new, modern looking hospital operates as a comprehensive medical center with 171 acute care beds and a wide range of healthcare services under one roof.

HEALTH CENTRAL PARK HISTORY

The West Orange Manor in Winter Garden was built in the late 1970's, becoming a long term care and rehabilitation facility. Today, renamed Health Central Park, it serves the community with 228 beds in a setting known for its excellence in providing care in a homelike setting. It also houses our Orthopaedic Rehabilitation Center.

THERE ARE MANY CREATIVE WAYS TO GIVE BESIDES AN OUTRIGHT CASH GIFT. YOUR GIFT CAN BE TAILORED NOT ONLY TO HELP YOU ACHIEVE YOUR PERSONAL GOALS, BUT ALSO TO MINIMIZE YOUR ESTATE TAXES.



SECURITIES

Your gift of securities instead of cash enables you to take an income tax deduction for the full value of the securities regardless of their cost. You will receive a receipt for the full value of the appreciated securities, but will not pay tax on the growth of the value of the shares. Please contact Health Central Foundation prior to making a gift of this kind.



GIFTS OF PROPERTY, INCLUDING LAND

Many people in our community have benefited from the tremendous growth in the value of real estate over the last few decades. By making a gift of real estate, donors can shelter capital gains. Some donors choose to transfer title of their residence, called a Life Estate gift, to Health Central Foundation. This gift enables you to continue living in your home for the rest of your life. You will be entitled to an income tax deduction in an amount that is determined by your age. By giving a Life Estate gift your residence is out of your estate for estate tax purposes. One added benefit is that you can enjoy making the gift at the present time to Health Central.

ESTATE GIFTS

Many people choose to make a gift in their will or trust. In this way you can leave an outright bequest of cash or a percentage of your estate to Health Central Foundation. You may benefit a specific area of the hospital or simply designate "the area of greatest need". Your estate will receive a tax deduction for the value of the gift, which can be used to offset taxes otherwise payable.

ENDOWMENTS

By establishing a fund in which the capital remains untouched you can create a lasting legacy in the name of your family or loved one. Annual interest earned can benefit any area of the hospital you choose.



LIFE INSURANCE

You can turn an immediate smaller gift into a larger future one, by choosing life insurance to enhance your giving. When you make Health Central Foundation the owner and beneficiary of your policy, future premium payments can be considered charitable gifts. Smaller donations can be used to finance the annual premiums of a life insurance policy, which eventually will result in a much larger gift to the Foundation. Annual receipts are issued for the value of the premiums paid. Alternatively, you may wish to leave an entire policy to Health Central Foundation, enabling your estate to benefit from a tax deduction.
